SUBORDINATION AGREEMENT

NOTICE:

THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT

WITNESSETH

to secure a Note in the sum of \$170,000.00, dated October 4, 2007, in favor of Washington Mutual Bank which Deed of Trust was recorded on November 5, 2007, in Book __ of Official Records, in the Office of the County 2007, Page 018888, Instrument No. Recorder of Klamath County, State of Oregon; and

WHEREAS, Owner has executed, or is about to execute, a Deed of Trust and Note in the sum of \$109,500.00, dated Arriver 1008, in favor of US Bank, NA, hereinafter referred to as "Lender," payable with interest and upon the terms and conditions described therein, which Deed of Trust is to be recorded concurrently herewith; and
