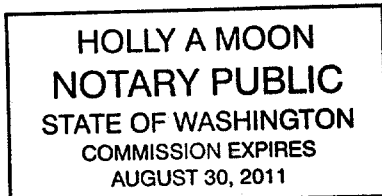

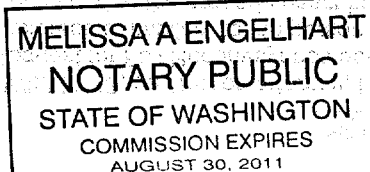
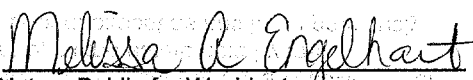
DEED OF RECONVEYANCE
