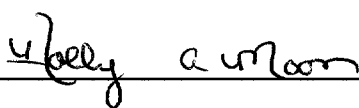

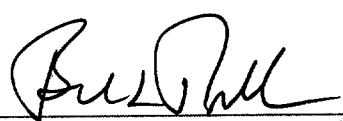

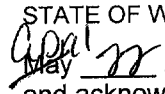

DEED OF RECONVEYANCE

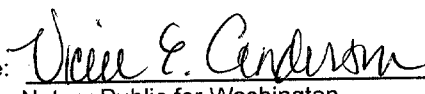
