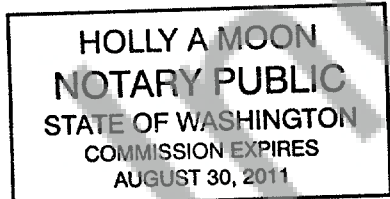



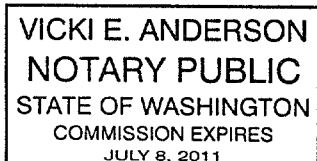
**DEED OF RECONVEYANCE**
