### AMENDMENT TO OREGON TRUST DEED

This Amendment to Deed of Trust (the "Amendment"), is made and entered into by International Church of the Foursquare Gospel (collectively the "Grantor"), and U.S. BANK N.A. (the "Beneficiary") as of the date set forth below.

#### RECITALS

A. The Grantor (or the Grantor's predecessor in interest, if different from the undersigned Grantor) executed a Trust Deed (the "Deed of Trust"), dated MAY 3, 2007. The "Land" (defined in the Deed of Trust) subject to the Deed of Trust is described as follows (or in Exhibit A hereto if the description does not appear below):

The real property is more commonly known as: 6100 Church Hill Street, Klamath Falls, OR 97603 with the legal description more fully described as follows:

That portion of Parcel 3 of Major Land Partition 22-91, Klamath County, Oregon, lying Northeasterly of Foothills Boulevard and subject to Property Adjustments 24-99 and 20-01, Klamath County, Oregon.

Real Property Tax I.D. No. Tax Map 3809-36BE, Lots 102 and 300, Tax Map 3809-36BC, Lot 100

B. The Deed of Trust was recorded in the office of the County Clerk for Klamath County, Oregon, on MAY 22, 2007, in Book \_\_\_\_\_, Page \_\_\_\_\_, or as Document No. 2007009277

C. The Grantor has requested that the Beneficiary permit certain modifications to the Deed of Trust as described below.

D. The Beneficiary has agreed to such modifications, but only upon the terms and conditions outlined in this Amendment.

#### TERMS OF AGREEMENT

In consideration of the recitals and mutual covenants contained herein, and for other good and valuable consideration, the Grantor and the Beneficiary agree as follows:

5. **Effectiveness of Prior Document.** Except as provided in this Amendment, all terms and conditions contained in the Deed of Trust remain in full force and effect in accordance with their terms, including any reference in the Deed of Trust to future credit secured by the Deed of Trust; and nothing herein will affect the priority of the Deed of Trust. All warranties and representations contained in the Deed of Trust are hereby reconfirmed as of the date hereof. All collateral previously provided to secure the Note continues as security, and all guarantees guaranteeing obligations under the Note remain in full force and effect. This is an amendment, not a novation.

6. **No Waiver of Defaults; Warranties.** This Amendment shall not be construed as or be deemed to be a waiver by the Beneficiary of existing defaults by the Grantor whether known or undiscovered. All agreements, representations and warranties made herein shall survive the execution of this Amendment.

7. **Counterparts.** This Amendment may be signed in any number of counterparts, each of which will be considered an original, but when taken together will constitute one document.

8. **Authorization.** The Grantor represents and warrants that the execution, delivery and performance of this Amendment and the documents referenced to herein are within the organizational powers (as applicable) of the Grantor and have been duly authorized by all necessary organizational action.

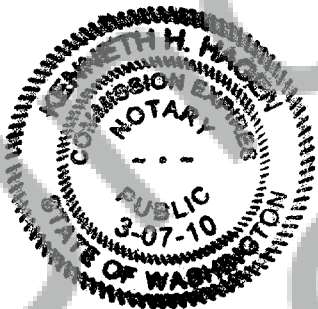
