KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Duane F. Martin, hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

Government Lots 21 and 22 in the SW¼ of Section 17, Township 36 South, Range 11 East of the Willamette Meridian, Klamath County, Oregon, excepting therefrom the West 990 and the Southerly 60 feet of the East 660 feet of Government Lot 21 and all of the Southerly 60 feet of Government Lot 22 in the SW¼ of Section 17, Township 36 South, Range 11 East of the Willamette Meridian.

Subject to covenants, conditions, restrictions, easements, reservations, rights, rights of way and all matters appearing of record.
