KNOW ALL BY THESE PRESENTS that Bonnie R. Beaudoin

hereinafter called grantor, for the consideration hereinafter stated, docs hereby remise, release and forever quitclaim unto George Joseph Beaudoin Jr., hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

Lot 2, Block 26 of Oregon Pines, as same as shown on plat filed June 30, 1969 duly recorded in the office of the county recorder of said county.

To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever. ⁰⁹

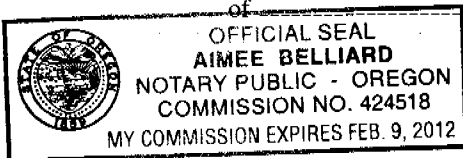
