NOTICE OF DEFAULT AND ELECTION TO SELL

Reference is made to that certain trust deed made by Robert C. Stull and Claire J. Stull, as grantors, to First American Title Ins. Pursuant to ORS 86.757, not later than 15 days before the sale date specified herein, the trustee shall provide a statement of information upon receipt of a written request from any interested party.


