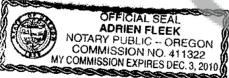

LEGAL DESCRIPTION:

A portion of Lot 3 Block 16 Original Town of Klamath Falls, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, being more particularly described as follows:
