Further, no action has been instituted to recover the debt, or any part thereof, now remaining secured by the trust deed, or, if such action has been instituted, such action has been dismissed except as permitted by ORS 86.735(4).

There is a default by grantor or other person owing an obligation, performance of which is secured by the trust deed, or by the successor in interest, with respect to provisions therein which authorize sale in the event of default of such provision. By reason of the default, the beneficiary has declared all sums owing on the obligation secured by the trust deed immediately due and payable, those sums being the following, to-wit:

1. **Principal Balance: \$14,259.41 together with interest on said sum at the rate of 10% per annum from September 20, 2007 until paid.**
2. **Any cost incurred in the maintenance of insurance coverage and for the payment of real property taxes.**
3. **Costs of obtaining evidence of title, the other costs and expenses of the Trustee and Trustee's and Attorney's fees.**
