KNOW ALL BY THESE PRESENTS this deed, made this 29th day of September, 2008, between Michael R. Long, TAX COLLECTOR, Klamath County, State of Oregon, "Grantor", and KLAMATH COUNTY, a Political Subdivision of the State of Oregon, "Grantee";

RECITALS

Pursuant to ORS 312.100 the said properties on the list attached hereto as "Exhibit B" were ordered sold to Klamath County, Oregon, subject to the right of redemption as provided by law. A General Judgment was entered in the Circuit Court of the State of Oregon for the County of Klamath on September 26, 2006, Case No. 06-00001FR in favor of Klamath County, Oregon, and against Joseph J. Adamick, et al.

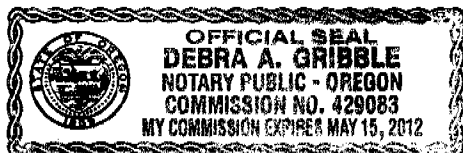
