- 1. Property affected: A portion of Section 41, T39S R09E WM, tax lot 1700, the Ronald & Phyllis Bodley Trust property in Klamath Falls, Klamath County, Oregon. Legal description of area of deed notice is included as Exhibit A. Maps of affected areas are included as Exhibits B and C.
- 2. In accordance with the Conditional No Further Action decision issued by the Oregon Department of Environmental Quality (DEQ) on March 11, 2008, a contaminated groundwater plume, originating on the ARCO property to the east (map tax lot: R-3909-010AD-01600-000), had migrated beneath the eastern portion of the Bodley Trust property and has been stabilized. The groundwater plume was stabilized by a combination of the injecting of oxygen release compound (ORC) into the shallow groundwater and also by the process of natural attenuation. Following the treatment with ORC, groundwater was monitored from June 18, 2004 through September 11, 2007.
- 3. The purpose of this deed notice is to document the location of the stabilized groundwater plume. DEQ should be notified of any proposed actions at the property described in this notice, which might result in disturbance of the stabilized area. 


