NOTICE OF DEFAULT AND ELECTION TO SELL

Reference is made to that certain trust deed made by Gordon W. Russell, as grantors, to Mountain Title Company of Klamath County, as trustee, in favor of Alfred L. 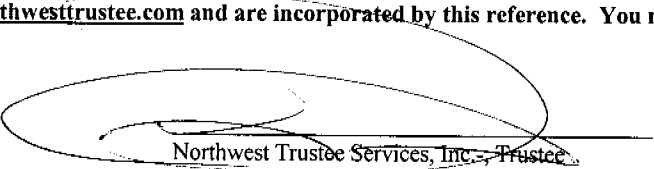

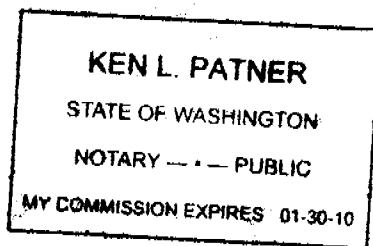

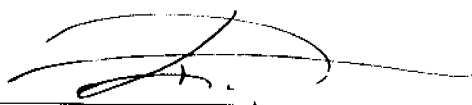
