## EASEMENT RELEASE AGREEMENT (EXTINGUISHMENT)

## RECITALS:

On April 17, 1958 an Easement Agreement was recorded in the real property records for Klamath County, Oregon in Volume 299, page 23, between Clyde L. Dehlinger and Georgia Dehlinger, as first parties, E.G. Born and Dorothy R. Born, as second parties, and Harold E. Dehlinger and Dorothy Dehlinger, as third parties, (hereinafter the "Easement Agreement"). A copy of said Easement is attached hereto as Exhibit "A" and by this reference incorporated herein.

Adkins are the successors in interest to a portion of the property owned by the third parties and further described on the attached Exhibit "B" attached hereto and by this reference incorporated herein.

- 2. Adkins hereby extinguishes and waives any interest they may have in the Easement Agreement.
- 3. It is the intent of Adkins that the Easement Agreement recorded in the real property records of Klamath County, Oregon at Volume 299, page 23 is hereby extinguished in its entirety and that such Easement Agreement have no further force and effect upon the property of Adkins or the other affected properties.
