## FIRST AMENDMENT TO DECLARATION OF TRUST CREATING THE KATHERINE A. BAUER TRUST

**PURSUANT TO** the powers reserved to herself as Trustor under Section 3.1 of that certain Declaration of Trust creating THE KATHERINE A. BAUER TRUST dated May 5, 1997 (the "Trust"), the undersigned hereby amends said Trust as follows:

- 1. Section 1.2, <u>Identification of Beneficiaries</u> is hereby amended, modified and changed to read as follows:
  - 1.2 <u>Identification of Beneficiaries.</u> The beneficiaries of the Trust, in order of priority, are:
    - a. Katherine A. Bauer, the Trustor, (hereinafter referred to as *Trustor Lifetime Beneficiary*);
    - b. Beneficiaries other than the Trustor, (hereinafter referred to as *Primary Beneficiaries*), as follows:

Robert Brasch Michelle Brasch Marcy Collins Richard Macgurn

- 2. Section 1.3 <u>Designation of Successor Trustee</u> is hereby amended, modified and changed to read as follows:
  - 1.3 <u>Designation of Successor Co-Trustees.</u> Upon the death of the Trustor, Richard Macgurn and Elizabeth S. Hinkens shall serve as Co-Trustees.
- 3. Section 2.5 <u>Administration of Primary Beneficiary Trust</u> is hereby amended, modified and changed to read as follows:
  - 2.5 <u>Administration of Primary Beneficiary Trust.</u> The Primary Beneficiary Trust shall be administered as follows:
  - 2.5a **Specific Bequests.** As soon as practical after the death of the Trustor, the Trustees shall distribute the following property to the Primary Beneficiaries:

Should any of the Primary Beneficiaries fail to survive the Trustor, the gift to such Beneficiary shall lapse and the property which would have otherwise been distributed to such Primary Beneficiary shall be added to the residue.

- 2.5b **Residue.** All of the rest, residence and remaining property of the Primary Beneficiary Trust or any property not otherwise disposed of under the terms of this Trust shall be subject to the limited power of appointment set forth herein sections 2.5c to 2.5e below.
- 2.5c <u>Inter Vivos Power of Appointment</u>. Subject to Section 2.5a, during the lifetime of Richard Macgurn the Trustees shall distribute the entire principal and income of the Primary Beneficiary Trust or any part thereof to such one or more persons on such terms and conditions, whether outright or in trust, as Richard Macgurn from time to time may appoint by a signed written instrument delivered to one or more of the Trustees, with such instrument specifically referring to and exercising this power of appointment.
- 2.5d <u>Testamentary Power of Appointment.</u> Subject to Section 2.5a, upon the death of Richard Macgurn, the Trustees shall distribute the entire principal and income of the Primary Beneficiary Trust or any part thereof to such one or more persons on such terms and conditions, either outright or in trust, as Richard Macgurn may appoint by an instrument in writing (including without limitation a Will or Codicil) signed by Richard Macgurn and delivered to the Trustees, specifically referring to and exercising this power of appointment.
- 2.5e <u>Nature of Powers of Appointment</u>. The powers of appointment set forth in Sections 2.5c and 2.5e are non-general, limited powers of appointment, and therefore, notwithstanding anything to the contrary herein contained, such power of appointment may not be exercised to any extent or in any manner in favor of

Richard Macgurn, Richard Macgurn's estate, creditors of Richard Macgurn or creditors of Richard Macgurn's estate.

- 4. Section 1.4 Acts of Trustees. is hereby amended, modified and changed to read as follows:
  - 1.4 Acts of Trustees. If there are two Trustees, either acting alone may consent and act to bind the Trust.
- 5. To assist me during the period of my disability, I hereby appoint Richard Macgurn as a Co-Trustee to serve as a Co-Trustee.
- Except as provided herein, THE KATHERINE A. BAUER TRUST, date May 5, 6. 1997, as amended this date, shall remain in full force and effect according to its terms.
