## WARRANTY DEED

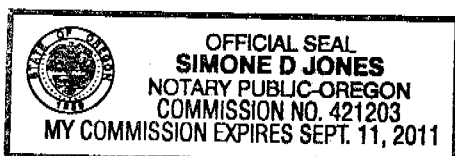
