Said sale will be held at the hour of **10:00 AM** in accord with the standard of time established by O.R.S. 187.110 on **5/11/2009** at the following place:



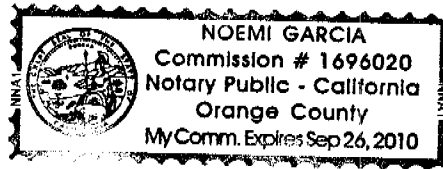
