Deed Of Trust Subordination Agreement

This Agreement is made this 15 day of January, 2009, by and between US Bank National Association ND. ("Bank") and GB Mortgage, LLC ("Refinancer").

Bank is the beneficiary under a deed of trust (the "Junior Deed of Trust") dated 9 day of June, 2008, granted by Michael E Sanchas and Dena M Sanchas, husband and wife, as tenants by the entirety ("Borrower"), and recorded in the office of the County Clerk Recorder, Klamath County, Oregon, in Book , Page , as Document 2008-010383, encumbering the real property described therein (collectively, the "Property"). ACCORDINGLY, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby agrees with Refinancer that the lien of the Junior Deed of Trust on the Property is and shall be and shall remain fully subordinate for all purposes to the lien of the Senior Deed of Trust on the Property, to the full extent of all sums from time to time secured by the Senior Deed of Trust; provided, however, that the total indebtedness secured by the Senior Deed of Trust does not exceed \$ 221,000.00, exclusive of interest thereon, amounts advanced to protect the lien and priority of the Senior Deed of Trust, and costs of collection, and provided further, that this agreement shall not be effective until each other mortgage or other lien recorded against the property (other than the Senior Mortgage) and each judgment that is a lien against the Property shall be subordinated Ωf οf the lien Ωf the Senior Mortgage. record
