CLULOW, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto FLOYD W. NELSON and CINDY L. NELSON, as Tenants by the Entirety, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anyway appertaining, situated in the County of **KLAMATH**, State of Oregon, described as follows, to wit:

The North 100 feet of Lot 12, **VILLA SAINT CLAIR**, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.
