WARRANTY DEED

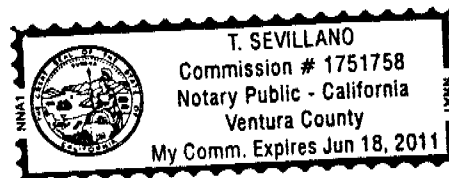
