STATUTORY WARRANTY DEED

The Klamath Tribes of Oregon, a federally recognized Indian Tribe of the State of Oregon, Grantor hereby conveys and warrants to The United States of America in trust for the Klamath Tribes of Oregon, Grantee, the following described real property free of encumbrances, except as specifically set forth herein, situated in Klamath County, Oregon, to wit:

PARCEL ONE: Portion of the NE1/4SE1/4 of Section 15, Township 36 South, Range 10 East of the Willamette Meridian that lays east of Squaw Flat Road, excepting therefrom the Northerly 165 feet thereof, in Sprague River, Klamath County, Oregon, containing 9.29 acres more or less.

PARCEL TWO: South 1/2 of Government Lot 20 excepting there from the easterly 220 feet, and Government Lot 21, excepting therefrom the easterly 220 feet of the northerly 120 feet, situated in Section 14, Township 36 South, Range 10 East, Willamette Meridian, Sprague River, Klamath County, Oregon. Containing 27.77 acres more or less.
