QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Gene Dennis Trustee of the Dennis Family Revocable Living Trust dated 02/11/2003, an undivided one-half interest and Marion L. Dennis Trustee of the Marion L. Dennis Revocable Living Trust dated 07/08/08, an undivided one-half interest, hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

A wedge of land located in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Sec. 18, Twp 24 S, Range 7 EWM, more particularly described as follows: Beginning at a 5/8" capped iron pin marking the true NW corner of the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of said Sec. 18; thence S 01° 00' 51" W along the West line of the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of said Sec. 18 a distance of 245.00'; thence S 89° 54' 39" E a distance of 24.93' to the true point of beginning; thence S 89° 54' 39" E a distance of 173.10'; thence S 01° 00' 51" W a distance of 3.20'; thence N 88° 59' 09" W a distance of 173.07'; thence N 00° 18' 41" E a distance of 0.40' to the point of beginning. Containing 0.012 acres, more or less. **Subject to** covenants, conditions, restrictions, easements, reservations, rights, rights of way and all matters appearing of record.
