QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Harold W. Strickland, Stanley R. Strickland and Virginia S. Tanner, as Tenants in Common, hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

A parcel of land situated in the NW¼ SW¼ of Section 5, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows: Commencing at the W¼ corner of said Section 5; thence S 0° 06' W 185.7 feet to the intersection of the West line of said Section 5 and the South line of Autumn Avenue; thence along said South line of Autumn Avenue N 89° 17' E, 1236.34 feet to the true point of beginning; thence continuing along South line N 89° 17' E, 60.0 feet; thence S 0° 18' E, 497.3 feet; thence S 89° 29' W, 60.0 feet; thence N 0° 18' W, 497.09 feet more or less to the point of beginning. Said parcel contains 0.68 acres more or less. Bearings and distances are based on Survey No. 65 on file in the Klamath County Surveyor's office. **Subject to** covenants, conditions, restrictions, easements, reservations, rights, rights of way and all matters appearing of record.

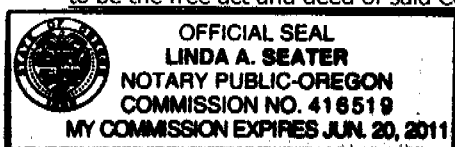
