The Klamath Tribes of Oregon, a federally recognized Indian Tribe of the State of Oregon, Grantor hereby conveys and warrants to The United States of America in trust for the Klamath Tribes of Oregon, Grantee, the following described real property free of encumbrances, except as specifically set forth herein, situated in Klamath County, Oregon, to wit:

Parcel 1: Lot 67 and Lot 68 of the Balsiger Tracts, according to the official plat thereof on file in the Office of the County Clerk of Klamath County, Oregon. Containing 0.155 acres more or less.

Parcel 2: Lots 69 through 74, Balsiger Tracts, according to the official plat thereof on file in the Office of the County Clerk of Klamath County, Oregon. Containing 0.464 acres more or less.
