MODIFICATION OF DEED OF TRUST

It is hereby agreed to extend the maturity date from February 28, 2009 to August 31, 2009.

This Section represents an unequivocal and irrevocable joint and several acknowledgement and agreement by the Agreement Parties that all of the Collateral secures payment and performance of all of the payment and performance obligations each of the Agreement Parties owes to Lender whether under this Agreement, the Related Documents, or otherwise, and that the Provisions of this Section are supplemental to and are expressly intended to reaffirm any ôcross-collateralization provisions contained in the Agreement, this Exhibit A, and the Related Documents.
