## RECITALS:

RECITALS: Gordon W. Russell, as grantors, executed and delivered to: Mountain Title Company of Klamath County, as trustee, for the benefit of Alfred L. Edgar, as beneficiary, a trust deed dated 11/02/94, duly recorded on 11/07/94 in the mortgage records of Klamath County, Oregon in Vol. M94 Pg. 34410 and subsequently assigned to Associates First Capital Corporation, sucessor by merger with Associates Financial Services Company, Inc. by Assignment recorded as In the trust deed, the real property described below ("Property") was conveyed by the grantor to the trustee to secure, among other things, the performance of the grantor's obligations to the beneficiary. The grantor thereafter defaulted in the performance of those obligations and such default(s) still existed at the time of the trustee's sale of the Property described below. \*Mortgage \*\* 2008-013886

Because of the default(s), the record beneficiary under the trust deed or its predecessor declared all sums secured by the trust deed immediately due and owing; therefore, a Notice of Default, containing an election to sell the Property and to foreclose the trust deed by advertisement and sale to satisfy grantor's obligations owed to the beneficiary was recorded in the mortgage records of the county in which the Property is located on 10/08/08, in 2008-13888.
