The Klamath Tribes of Oregon, a federally recognized Indian Tribe of the State of Oregon, Grantor hereby conveys and warrants to The United States of America in trust for the Klamath Tribes of Oregon, Grantee, the following described real property free of encumbrances, except as specifically set forth herein, situated in Klamath County, Oregon, to wit:

A tract of land situated in the \$1/2\$1/2\$E1/4\$E1/4 of Section 3, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon. Described as follows: Beginning at a point North 01 degrees 14'00" West 30 feet and South 89 degrees 26'00" West 150 feet from the Southeast corner of said Section 3; thence North 01 degrees 14'00" West 225 feet to a point; thence South 89 degrees 26'00" West 212 feet; thence South 00 degrees 34'00" East 225 feet to the Northerly line of Hilyard Avenue; thence North 89 degrees 26'00" East 214.62 feet, more or less to the point of beginning.
