Lots 5 and 6 in Block 10 of Chelsea Addition, according to the official plat thereof on file in the Office of the County Clerk of Klamath County, Oregon. Containing 0.23 acres more or less.

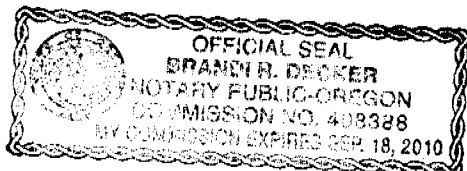
