THIS INDENTURE, Made this Joseph D. McDonald called trustee, and James LaCoste, Jr. and Robert L. Thibedeau hereinafter called the second party; WITNESSETH: RECITALS: Smith's Custom Construction, Inc. Aspen Title & Escrow __, as trustee, for the benefit James LaCoste, Jr. and Robert L. Thibedeau as beneficiary, a certain trust deed dated August 23, 2006 recorded August 28, 2006 Klamath County, Oregon, And book week work was a supplied in the county of the c was conveyed by the grantor to the trustee to secure, among other things, the performance of certain obligations of the grantor to the beneficiary.
