KNOW ALL BY THESE PRESENTS that LaVonne Moore

hereinafter called grantor, for the consideration hereinafter stated, to grantor paid by Julie McDonnell

hereinafter called grantee, does hereby grant, bargain, sell and convey unto the grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

A portion of tract no.25,Altamont small farms,in the county of Klamath,State of Oregon,described as follows:beginning at a pointin the northerly boundary of tract No.25 of Altamont small farms;said point being 132.0 feet distant Westerly from the North easterly corner of said tract,and running thence North 88°46'west along the said Northerly boundary line of said tract 132.0 feet;thence south 9'11' West 323.2 feet,more or less,to a point in the Southerly bounery of said tract;thence South 89° 48' east along the said boundary of the tract 132.0 feet;thence North 0°11' east322.0 feet to the point of the beginning.


