**LIMITED POWER OF ATTORNEY**

**US Bank National Association**, a national banking association organized and existing under the laws of the United States of America, 180 East Fifth Street, Corporate Trust, 2<sup>nd</sup> Floor, St. Paul, MN 55101 hereby constitutes and appoints CitiMortgage Inc., and in its name, aforesaid Attorney-In-Fact, by and through any officers appointed by the Board of Directors of CitiMortgage, Inc. to execute and acknowledge in writing or by facsimile stamp all documents customarily and reasonably necessary and appropriate for the task described in items (1) through (4) below; provided however, that the documents described below may only be executed and delivered by such Attorneys-In-Fact if such documents are required or permitted under the terms of the related servicing agreements and no power is granted hereunder to take any action that would be adverse to the interests of the Trustee or the Holders. This Power of Attorney is being issued in connection with CitiMortgage, Inc.'s responsibilities to service certain mortgage loans (the "Loans") held by US Bank National Association in its capacity as Trustee. These Loans are comprised of Mortgages, Deeds of Trust, Deeds to Secure Debt and other forms of Security Instruments (collectively the "Security Instruments") and the Notes secured thereby.

1. Demand, sue for, recover, collect and receive each and every sum of money, debt, account and interest (which now is, or hereafter shall become due and payable) belonging to or claimed by US Bank National Association, and to use of take any lawful means for recovery by legal process or otherwise.
