WHEREAS, Grantors are the respective owners of the various parcels of real property as described on Exhibit "A," attached hereto and incorporated herein.

WHEREAS, Grantees are the respective owners of the various parcels of real property as described on Exhibit "B," attached and hereto and incorporated herein.

WHEREAS, the parties desire to enter into a perpetual nonexclusive access easement so that the Grantees' respective parcels will have access to a public roadway.

NOW, THEREFORE, for good and valuable consideration, Grantors have agreed to provide Grantees with a perpetual nonexclusive access easement over and across the existing roadway located on each Grantor's respective or jointly owned parcel as follows:

- 1. Grant of Easement. Each Grantor conveys to each Grantee, its successors and assigns, a perpetual nonexclusive thirty (30) foot easement for ingress and egress over and across the existing roadway located on each of the Grantors respective parcels as identified in Exhibit "A" and as shown on the map labeled Exhibit "C." The center of this easement is the existing road's centerline, with the easement's boundaries being fifteen (15) feet on each side of the road's centerline.
- 2. Use. Grantees, their successors, assigns and invitees shall each have use of the easement for access to and from Grantees' parcels. In connection with such use, Grantees are permitted to maintain and repair the facilities within the easement, including the existing road and bridge, as may be necessary for its reasonable and convenient use. In the event any

Grantee intentionally or negligently damages any portion of the easement, that Grantee will be solely responsible for the cost of any necessary repairs.

Grantors, their successors and assigns, shall have the right to use the existing roadway that is subject to this easement, and may allow others to use the existing roadway, so long as such use does not unreasonably interfere with Grantees' right to also use the roadway. All permitted users of the easement shall cooperate during periods of joint use so that each person's use shall cause a minimum interference to the other's use.

The parties do not intend, as a result of this easement grant, to create or hold out the existing road within this easement as a public way and such road may be designated at each terrinus thereof, by suitable notices, as a private road with passage there over undertaken at the user's own risk.

- 3. Successor's Interest. This easement shall be appurtenant to and run with Grantees' parcels, and shall be binding on each Grantor's heirs, executors, administrators, assigns and successors in interest.
- **4. Priority.** This easement is granted subject to all prior easements or encumbrances of record.
- 5. Counterparts. This easement may be executed in counterparts, each of which will be considered an original and all of which together will constitute a single agreement.


