RECITALS:

A. DARREN CARLSON AND SHARON CARLSON, Grantor, executed and delivered to AMERITITLE, Trustee for the benefit of STEVEN A. LAMBOURNE AND LINDA R. LAMBOURNE, TRUSTEES OF THE LAMBOURNE TRUST, DATED MARCH 7, 1980, Beneficiary, a Trust Deed dated November 7, 2007 and recorded on January 31, 2008, in the Official Records of Klamath County, Oregon as Recording No. 2008-001314 (the Trust Deed). In the Trust Deed, the following described real property (the Real Property) was conveyed by the Grantor to the Trustee to secure the performance of certain obligations to the Beneficiary:

Lot 26 in Block 1 of Tract 1110, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Thereafter the Grantor defaulted in performance of the obligations secured by the Trust Deed. The default still existed at the time of sale by the Trustee to the Grantee.

- B. NANCY K. CARY was appointed Successor Trustee of the Trust Deed. The appointment was recorded on February 12, 2009 in the Official Records of Klamath County, Oregon as Recording No. 2009-002063.
- C. The Beneficiary declared the Grantor of the Trust Deed to be in default. The reasons for the declaration of default, the Beneficiary's election to declare all sums due to it immediately due and the Beneficiary's election to foreclose the Trust Deed by advertisement and sale to satisfy the Grantor's obligations was recorded on February 12, 2009 in the Official Records of Klamath County, Oregon as Recording No. 2009-002064.
- D. After recording the Notice of Default and Election to Sell, the Trustee gave notice of the time and place set for sale of the Real Property. Notice of the sale was given:
- 1. To all persons entitled to receive such notice by mailing the notice to them at their last known addresses by both first class mail and certified mail, return receipt requested. The notice was mailed to them more than 120 days before the Trustee conducted the sale. An Affidavit of Mailing of such notice was recorded in the Official Records of Klamath County, Oregon as Recording No. 2009-008158, prior to the day the Trustee conducted the sale.
- 2. By publishing such notice in the <u>Herald & News</u>, a newspaper of general circulation in Klamath County, Oregon, once a week for four successive weeks. The last publication was more than 20 days prior to the day the Trustee conducted the sale. An Affidavit of Publication of such notice was recorded in the Official Records of Klamath County, Oregon as Recording No. 2009-008158, prior to the day the Trustee conducted the sale.
- E. On the date of the Notice of Sale, the Trustee did not have actual notice of any person claiming an interest which was subsequent to the Trustee's interest in the Real Property, except for those persons named in the affidavits referred to in Recital D. of this deed. The Trustee hereby certifies that any valid requests for information under 2003 OR Laws Ch 251 have been responded to within the time allowed by the statute. The property was not occupied at the time notice was given. An Affidavit of Nonoccupancy was recorded in the Official Records of Klamath County, Oregon as Recording No. 2009-008158, prior to the date the Trustee conducted the sale.
