QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto William E. Adams, hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

The Southerly 80 feet of Lots 3 and 4, Block 65, Buena Vista Addition to the City of Klamath Falls, Oregon, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon. Saving and Excepting a strip of one foot in width off the Easterly end of said premises heretofore conveyed by the Klamath County Development Co. to the City of Klamath Falls, Oregon, for street purposes by Deed recorded in Book 46 at Page 155, Deed Records of Klamath County, Oregon. **And** Lots 5 and 6, Block 65, Buena Vista Addition to the City of Klamath Falls, Oregon, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon. Excepting therefrom the following: Beginning at a 1/2" iron pin marking the Southwest corner of said Block 65; thence North 140.10 feet to a 1/2" iron pin; thence East 88.26 feet to a 1/2" iron pin; thence East 6.74 feet to a 1/2" iron pin; thence South 140.10 feet to a 1/2" iron pin; thence West 6.74 feet to a 1/2" iron pin; thence West 88.26 feet to the point of beginning. **Subject to** covenants, conditions, restrictions, easements, reservations, rights, rights of way and all matters appearing of record.

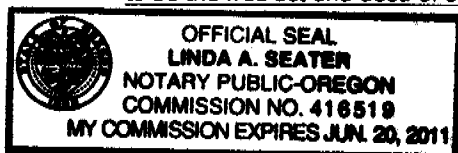
