Said Street was vacated by City of Klamath Falls Ordinance #6642, recorded November 12, 1992 in Book M92 at page 26874.

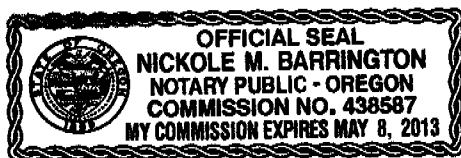

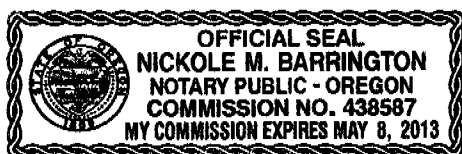
