



INDENTURE OF ACCESS

THIS INDENTURE, made and executed this 17th day of August, 2009, by and between the STATE OF OREGON, by and through its DEPARTMENT OF TRANSPORTATION, hereinafter called "State", and TIMOTHY J. MOORE AND HEATHER L. MOORE, HUSBAND AND WIFE, hereinafter called "Owner".

WHEREAS, State by Permanent Slope Easement and Conveyance of Access recorded July 28, 1964, in Volume 355, Page 38, Klamath County Deed Records, acquired certain property; which Permanent Slope Easement and Conveyance of Access, in part, reserved access rights, for the service of the grantor's remaining property, to and from the Southerly side of the Klamath Falls-Lakeview Highway, opposite Engineer's Station 92+80, (Reserved Access Rights); and

WHEREAS, Owner, by deed recorded June 13, 2008, in Document No. 2008-008600, Klamath County Deed Records, acquired fee title to that portion of said remaining property affected by the access changes herein made; and

WHEREAS, Owner has requested that Owner's Reserved Access Rights set out above be terminated; and

WHEREAS, State is agreeable to the granting of Owner's request.

NOW THEREFORE, THIS INDENTURE WITNESSETH, that OWNER does convey unto State, its successors and assigns, Owner's Reserved Access Rights as set forth above.

The other remaining provisions in the above-mentioned Permanent Slope Easement and Conveyance of Access shall remain in full force and effect as fully as if set forth herein.

Owner represents and warrants that no one, other than Owner, is using or entitled to use the Reserved Access Rights herein relinquished.

In construing this document, where the context so requires, the singular includes the plural and all grammatical changes shall be made so that this document shall apply equally to corporations and to individuals.


