**NOTICE OF DEFAULT AND ELECTION TO SELL**

Reference is made to that certain trust deed made by STACI R. 

Due to potential conflicts with federal law, persons having no record legal or equitable interest in the subject property will only receive information concerning the lender's estimated or actual bid. 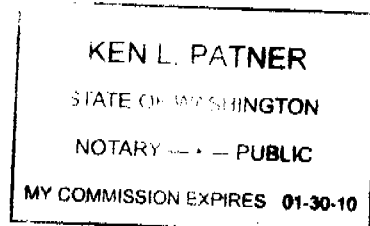


