## QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Dusty Surface

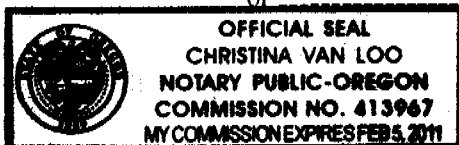
