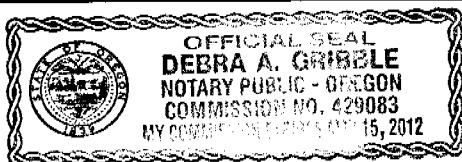

The foreclosure list includes all properties appearing on the tax rolls in the office of the Tax Collector of the County on which taxes have been delinquent for more than three years from the earliest date of such delinquency of such taxes levied and charged thereon, which have not been paid. By reason of the expiration of more than three years from the earliest date of delinquency, together with all special assessments, fees or other charges against these properties, which are due and unpaid for any year or years for which ad valorem taxes are due, the items of all such delinquent taxes, special assessments, fees or other charges against each of the several properties included in the said foreclosure list have become subject to foreclosure under the provision of ORS Chapter 312.

The amounts shown by the foreclosure list to be due and owing against the several parcels of property described therein include all taxes for 2008 and prior years which were unpaid and delinquent as of August 15, 2009, together with the accrued interest thereon. The several defendants and each and every other person owning or claiming to own, or having or claiming to have any interest in any of the properties have neglected and refused to pay such delinquent amounts and interest and that there is due, and unpaid to Plaintiff, Klamath County, the respective sums set out in the foreclosure list after the description of each of the several properties and in addition thereto, interest on each of said sums at the rate of 13.33 percent per month from the years of delinquency and subsequent tax years, with said interest accruing through September 15, 2009.

Each of the properties described in the foreclosure list was fully listed for taxation in or for each of the specified years. The assessments, equalization, levies of taxes, notification procedures and all other acts required by law to make such taxes first liens on said properties were duly and regularly made and done, and the liens and claims of plaintiff to each of the several properties are first liens and paramount to any other interest, title estate or claim in or on any of said properties. The claims or interest of all defendants including unknown owners, are inferior to and subject to the tax liens of Klamath County.

WHEREFORE, Plaintiff prays for judgment of this court, pursuant to ORS 312.090, as follows:

a. For the full amount of taxes and interest, special assessments, fees or other charges charged against each of the several properties included in said foreclosure list, together with interest thereon at the rate of 13.33 percent per month from the years of delinquency and subsequent tax years, to the date of such judgment, and securing interest on said judgment at the legal rate of interest.

b. That the liens and claims of plaintiff to each of the several properties are first liens and paramount to any other interest, title estate or claim in or on any of said properties made or potentially made by any other person or entity, known or unknown.

c. That the several items detailed in this Application are hereby forever foreclosed, subject only to lawful redemption as detailed by statute.

d. That the resulting judgment is a several judgment against and a lien upon each parcel of property detailed in this Application.

e. Directing the clerk of the court to serve on the tax collector of Klamath County a certified copy of the judgment, included in which shall be a list of the properties so ordered sold, with the several amounts due thereon and that said judgment, so delivered to the tax collector, shall constitute and be considered for all intents and purposes a certificate of sale to Klamath County for each of the properties therein described.

f. That said tax collector and Klamath County may take further steps in this matter as are provided by law.

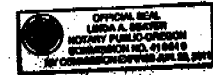
