COMES NOW, Friends of Train Mountain, Inc., an Oregon corporation, and states as follows:

WHEREAS, Quentin L. Breen, Trustee of the Train Mountain Foundation, Train Mountain, Inc., and Train Mountain Railroad Museum (collectively the "Grantors"), granted to Friends of Train Mountain, Inc. a Conservation Easement dated October 24, 2007, which was recorded in the Klamath County records at Recording Number 2007-018428, and recorded on October 26, 2007, concerning certain property a portion of which is legally described in Exhibit A attached hereto ("Property"):

WHEREAS, Friends of Train Mountain, Inc. is willing to allow the placement of wireless communications facilities on certain portions of the Property; and

WHEREAS, Friends of Train Mountain, Inc. is willing to convey a partial release of the Conservation Easement to the Grantors.

WHEREFORE, Friends of Train Mountain, Inc hereby:

- 1. Finds that the installation, operation, maintenance, repair, replacement, upgrading and removal of wireless communications facilities above the 4710' contour on Parcel 8 which is legally described in Exhibit A does not materially impair or interfere with the significant Conservation values of the Protected Property, and is consistent with the purpose of the Conservation Easement.
- 2. Voluntarily grants and conveys to the Grantors a partial reconveyance of the Conservation Easement: (a) on Parcel 8 for the installation, operation, maintenance, repair, replacement,



upgrading and removal of wireless communications facilities above the 4710' contour on Parcel 8, (b) access to the wireless communications facilities from the public right of way across Parcels 8, 9, 11, and 12 using the Baldwin 4-2-2 Gate on Highway 422, the existing O.C. &E. Road to the existing Great Northern Road to the existing Steiger Butte Road up the east side of Steiger Butte as located in Exhibit X, and (c) installation, operation, maintenance, repair, replacement, upgrading and removal of utility services to the wireless communications facilities above the 4710' contour provided utility services are (i) placed under existing O. C. & E. Road between Baldwin 4-2-2 Gate and Great Northern Road, under the existing Great Northern Road from O. C. & E. Road to Steiger Butte Road, and under the existing Steiger Butte Road from the Great Northern Road to contour 4710 as located in Exhibit X or, (ii) are overhead on the route of the existing pole lines across Parcels 8, 9, 11, and 12.


