QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Bret S. Roberts, hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

A portion of Lot 55, Block 6, Oregon Pines, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, and more particularly described as follows: Beginning at the SW corner of Lot 9 of said Block 6; thence N 41° 34' 47" W, 588.40 feet to a line running from the East quarter corner of Section 16 to the NW corner of Lot 12; thence N 50° 14' 29" East, along said line, 643.60 feet; to the Northwest corner of Lot 12; thence S 09° 14' 29" West, along the Westerly line of Lot 12, 394.08 feet to the Northwest corner of Lot 11; thence South 14° 20' 43" East, along the Westerly line of Lot 11, 314.82 feet to the Northwest corner of Lot 9; thence S 45° 42' 51" West, along the Northwesterly line of Lot 9, 183.94 feet to the point of beginning. **Subject to** covenants, conditions, restrictions, easements, reservations, rights, rights of way and all matters appearing of record.

Before signing or accepting this instrument, the person acquiring fee title to the property should check with the appropriate city or county planning department to verify that the unit of land being transferred is a lawfully established lot or parcel, as defined in ORS 92.010 or 215.010, to verify the approved uses of the lot or parcel, to determine any limits on lawsuits against farming or forest practices as defined in ORS 30.930, and to inquire about the rights of neighboring property owners, if any, under ORS 195.300, 195.301 and 195.305 to 195.336 and Sections 5 to 11, Chapter 424, Oregon Laws 2007.

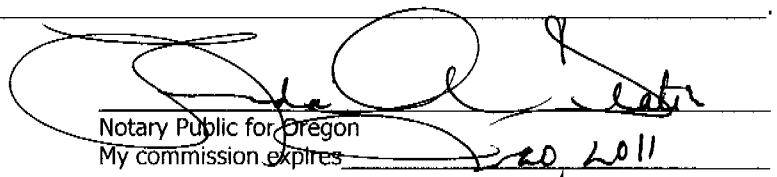
