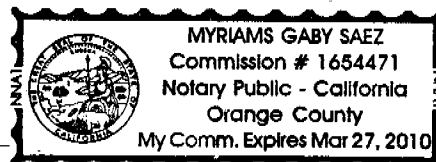

NOTICE TO TENANTS
