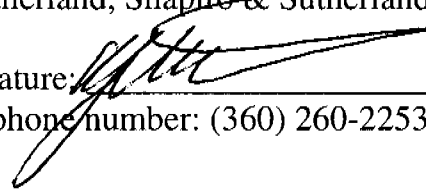
1. You can pay the amount past due or correct any other default, up to five days before the sale.
