DEED

KNOW ALL BY THESE PRESENTS this deed, made this 8th day of June, 2007, between Michael R. Long, TAX COLLECTOR, Klamath County, State of Oregon, "Grantor", and KLAMATH COUNTY, a Political Subdivision of the State of Oregon, "Grantee";

RECITALS

Pursuant to ORS 312.100 the said properties attached hereto as "Exhibit B" were ordered sold to Klamath County, Oregon, subject to the right of redemption as provided by law. A General Judgment was entered in the Circuit Court of the State of Oregon for the County of Klamath on October 20, 2004, as amended on October 22, 2004, and as amended to Second Amended General Judgment on June 7, 2005, Case No. 04-00001FR in favor of Klamath County, Oregon, and against Volturno Adamo, et al.

The said properties attached hereto as "Exhibit B" have been held by said Klamath County, Oregon, for a period of two years from and after the date of said Second Amended General Judgment, and no redemption has been made. In accordance with ORS 312.125, being not less than one year prior to the expiration of the period of redemption expiring under the Second Amended General Judgment, the Tax Collector gave written Notice by both certified and regular first class mail to all persons entitled to redeem the property whose interests appeared in the records of the county as of the date the foreclosure proceedings were instituted.

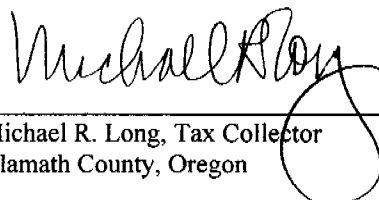
A general Notice of the expiration of redemption period has been given in the duly designated newspaper of general circulation and published in Klamath County, Oregon, to wit, in two weekly issues in the Herald and News on May 18th and May 26th, that were not more than 30 days nor less than 10 days, prior to the expiration of the period of redemption of any property ordered sold to Klamath County under the Second Amended General Judgment. In accordance with the laws of the State of Oregon for and in consideration of the Second Amended General Judgment as aforesaid, I have this day executed this Deed conveying to Klamath County, a Political Subdivision of the State of Oregon, the following described properties attached hereto as "Exhibit B".

The said properties were formerly owned by the said Defendants appearing in the tax roll as the respective owners bearing the tax foreclosure list number and the amount of judgment as indicated, all respectively, for each property sold by said foreclosure to said Klamath County, Oregon, and not redeemed as provided by law.

NOW, THEREFORE, I MICHAEL R. LONG, Grantor, by virtue of the statutes of the State of Oregon, the Second Amended General Judgment and Order has expired, do hereby sell and convey unto Klamath County, Oregon, as Grantee, and its assigns forever, the property described in the attached "Exhibit B".

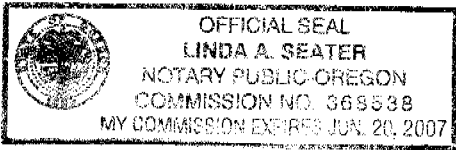

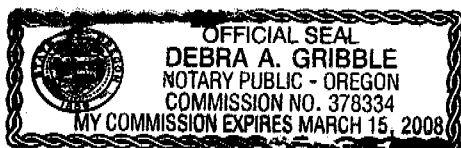
