TRUSTEE'S DEED

THIS INDENTURE, made January 7, 2010, between Northwest Trustee Services, Inc., hereinafter called the Trustee and Wells Fargo Bank, N.A., hereinafter called the second party;

RECITALS:

RECITALS: DARRELL L. WALTERS and VALERIE WALTERS, as tenants by the entircty, as grantors, executed and delivered to: First American Title Insurance Company, as trustee, for the benefit of Mortgage Electronic Registration Systems, Inc. solely as nominee for LOAN CORRESPONDENTS INC., DBA CAPITAL FUNDING GROUP, A CALIFORNIA CORPORATION, as beneficiary, a trust deed dated 01/10/05, duly recorded on 01/20/05 in the mortgage records of Klamath County, Oregon in Volume M05 Page 04268 and subsequently assigned to Wells Fargo Bank, N.A. by Assignment recorded as 20098821. In the trust deed, the real property described below ("Property") was conveyed by the grantor to the trustee to secure, among other things, the performance of the grantor's obligations to the beneficiary. The grantor thereafter defaulted in the performance of those obligations and such default(s) still existed at the time of the trustee's sale of the Property described below.

Because of the default(s), the record beneficiary under the trust deed or its predecessor declared all sums secured by the trust deed immediately due and owing; therefore, a Notice of Default, containing an election to sell the Property and to foreclose the trust deed by advertisement and sale to satisfy grantor's obligations owed to the beneficiary was recorded in the mortgage records of the county in which the Property is located on 06/25/09, in 2009-8823.

After recording the Notice of Default, the trustee gave notice to the grantor(s) and/or occupants pursuant to the requirements of section 20 and 21, Chapter 19, Oregon laws 2008 ("Bill") by mailing said notice by both first class and certified mail with return receipt requested. If the foreclosure was stayed and released from stay, copies of an Amended Notice of Sale in the form required by ORS 86.755(6) were mailed within thirty days after release from stay by registered or certified mail to the last-known address of those persons listed in ORS 86.740 and 86.750(1) and any person requesting notice who was present at the time and place set for the sale which was stayed. Further, the trustee published a copy of the Trustee's Notice of Sale in a newspaper of general circulation in each county in which the Property is located, once a week for four successive weeks; the last publication of Notice of Trustee's Sale occurred more than twenty days prior to the date of sale. Compliance with the Bill and the mailing, service and publication of the Trustec's Notice of Sale are evidenced by one or more affidavits or proofs of service duly recorded prior to the date of sale in the official records of the county in which the Property is located.
