NOTICE OF DEFAULT AND ELECTION TO SELL

- 1. This notice of default and election to sell is recorded pursuant to ORS 86.735(3) with respect to that deed of trust (the "Trust Deed") dated **October 9, 2008,** by **John A. Moore and Alice P. Moore** (the "Grantor"), to **David A.
