WARRANTY DEED

Krauss, "Grantors," hereby conveys, grants, sells and warrants, to **Earl Dennis Krauss and Barbara Joan Krauss**, as Trustees of the **Krauss Joint Revocable Living Trust** under agreement dated February 9, 2010, or to such Successor Trustee(s) of such trust(s) created under such instrument(s) as may hereafter be appointed, "Grantee," the following real property, situated in **Klamath County**, State of Oregon, free of encumbrances except for matters of public record:

LOT 7 IN BLOCK 16, RIVERSIDE ADDITION TO THE CITY OF KLAMATH FALLS, EXCEPTING THEREFROM THAT PORTION OF LOT 7 LYING SOUTHEASTLY OF A LINE, SAID LINE BEING A STRAIGHT LINE 30 FEET NORTHWESTERLY FROM THE PARALLEL WITH THE AS CONSTRUCTED "L" LINE SHOWN ON THE PLAT AND PROFILE OF ROGERS STREET, IMPROVEMENT UNIT #184, DATED JUNE, 1965, ON FILE IN THE OFFICE OF THE CITY ENGINEER, CITY HALL, KLAMATH FALLS, OREGON.

THE LIMITATIONS CONTAINED HEREIN EXPRESSLY DO NOT RELIEVE GRANTORS OF ANY LIABILITY OR OBLIGATIONS UNDER THIS INSTRUMENT, BUT MERELY DEFINE THE SCOPE, NATURE, AND AMOUNT OF SUCH LIABILITY OR OBLIGATIONS.

THIS INSTRUMENT WILL NOT ALLOW USE OF THE PROPERTY DESCRIBED IN THIS INSTRUMENT IN VIOLATION OF APPLICABLE LAND USE LAWS AND REGULATIONS.
