In consideration of the mutual promises and agreements exchanged, Lender and Borrower agree as follows. (Notwithstanding anything contrary contained in the Note or Security Instrument).

1. As of May 1, 2009, the amount payable under the Note and Security Instrument (the "Unpaid Principal Balance") is U.S. \$187,635.83

2. The Borrower promises to pay the Unpaid Principal Balance, plus interest, to the order of the Lender. Interest will be charged on the Unpaid Principal Balance at a yearly rate of 4.500%, beginning May 1, 2009, The Borrower promises to make monthly payments of principal and interest of U. S. \$1,001.46 beginning on the 1st day of June, 2009, and continuing thereafter on the same day of each succeeding month until principal and interest are paid in full.
