MODIFICATION OF DEED OF TRUST

THIS MODIFICATION OF DEED OF TRUST dated March 11, 2010, is made and executed between Steven D. Hanlin ("Grantor") and PremierWest Bank, whose address is Southern Oregon Loan Production Office, P O Box 40, 503 Airport Road, Medford, OR 97501 ("Lender").

DEED OF TRUST. Lender and Grantor have entered into a Deed of Trust dated February 24, 2005 (the "Deed of Trust") which has been recorded in Klamath County, State of Oregon, as follows:

Original Deed of Trust in the principal amount of \$400,000.00 recorded as Document No. Volume M05, Page 12523-29 on February 25, 2005 in the Official Records of Klamath County, State of Oregon; followed by a Modification of Deed of Trust dated February 22, 2006 in the principal amount of \$400,000.00; followed by a Modification of Deed of Trust dated December 21, 2006 in the principal amount of \$400,000.00; followed by a Modification of Deed of Trust dated March 12, 2007 in the principal amount of \$193,676.84; followed by a Modification of Deed of Trust dated March 6, 2008; followed by a Modification of Deed of Trust dated March 19, 2009; followed by a Modification of Deed of Trust dated June 23, 2009; followed by a Modification of Deed of Trust dated October 26, 2009; and followed by a Modification of Deed of Trust dated January 14, 2010.

REAL PROPERTY DESCRIPTION. The Deed of Trust covers the following described real property located in Klamath County, State of Oregon:

Lot 1 of GARDEN TRACTS, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

The Real Property or its address is commonly known as 4329 and 4333 Shasta Way, Klamath Falls, OR 97603. The Real Property tax identification number is 3809-035CC-05800-000.


MODIFICATION. Lender and Grantor hereby modify the Deed of Trust as follows:

It is hereby agreed to extend the maturity date from February 15, 2010 to August 15, 2010.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.



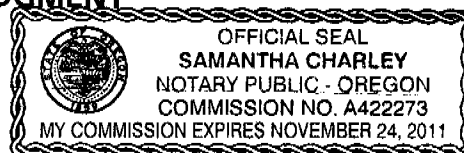

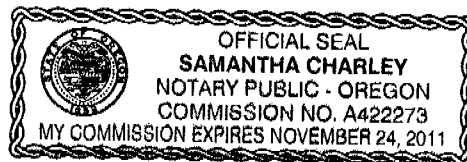
