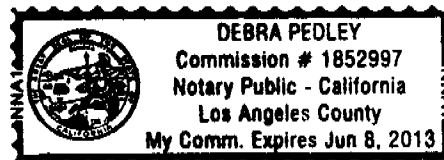

## **NOTICE TO TENANTS**
